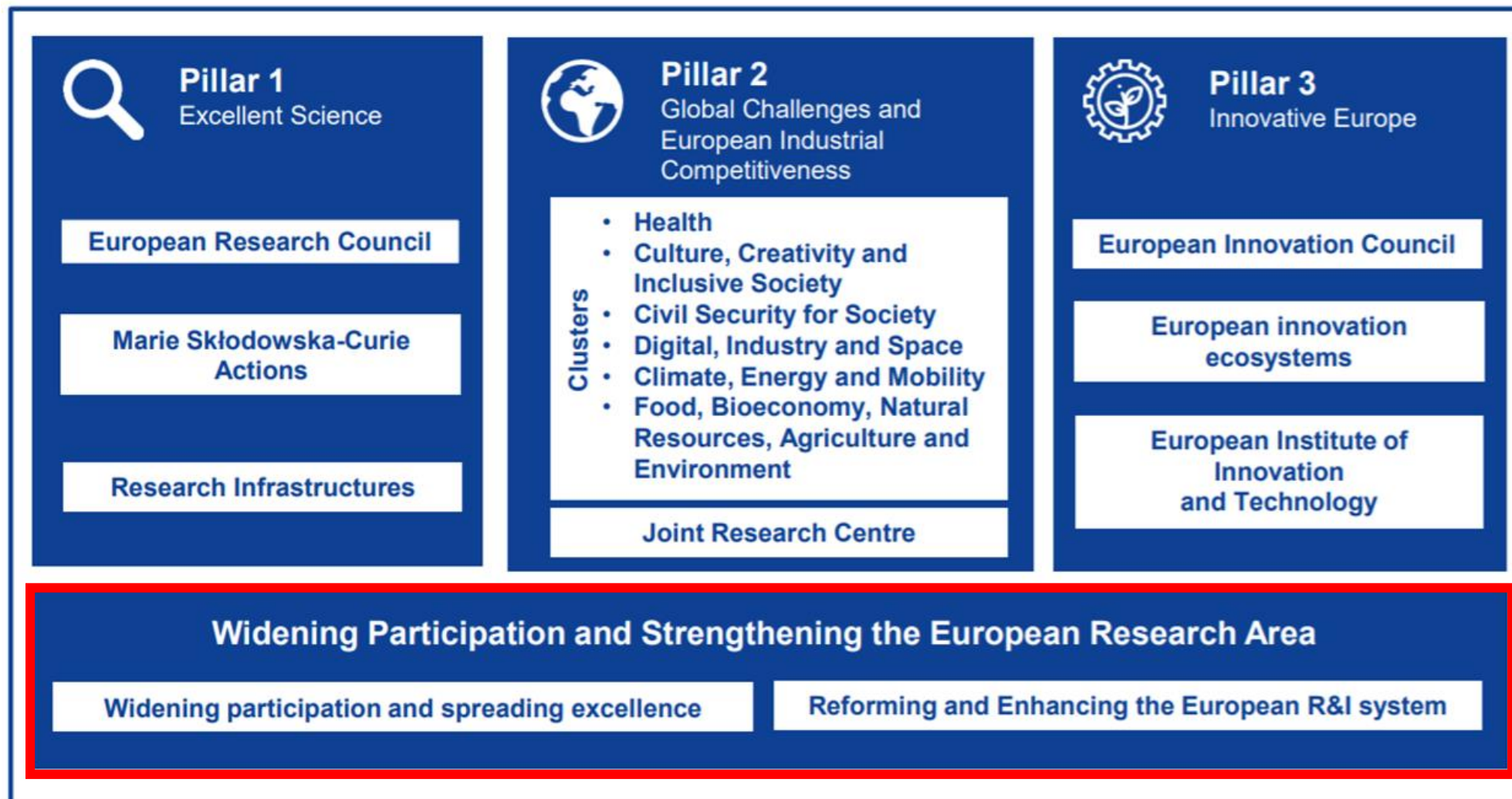

# WIDENING AND ERA: RATIONALE

## WIDENING PART

**Significant disparities of R&I performance within the EU and low participation of some countries in FPs** due to:

- reduced access to international networks
- system learning effects
- problems with information, communication and training
- insufficient national R&D investments
- lack of synergies between national research systems and EU research landscape

## ERA PART

Reforming and enhancing the EU R&I system - calls structured around 4 strands corresponding to 4 objectives of the new ERA:

1. Prioritise investments and reforms
  2. Improve access to excellence
  3. Translate R&I results into the economy
  4. Deepening the ERA
- **principle of excellence remains the cornerstone for all investments under ERA**

# WP 2021 – 2022: OBJECTIVES

- Underpin geographical diversity and build the necessary capacity to allow successful participation in the R&I process
- Foster brain circulation across ERA through mobility of researchers and innovators, to address current imbalances
- Improve research management capacities
- Deepen the ERA
- Reinforce the interaction between education and research by dissemination and exploitation of research results
- Strengthen collaborative links across EU and open up European R&I networks

  - Widening countries in HORIZON: 15 MS (13 NMS + PT and EL) + [9 EU Outermost regions](#) + AC
- **Advancing Europe Package**
  - **Cross-cutting widening measures**
    - HOP ON FACILITY (accession of one additional partner from a WC to consortium funded under Pillar 2 with a valid GA without any WC partner) 
    - RECOGNITION OF PARTICIPATION (certificate for coordinators from WC) 
    - MATCHMAKING (Joint Brokerage Events with Pillar 2 clusters, study visits) 
    - PROPOSAL REVIEW / CHECK (trainings, professional reading) 
  - **Widening instruments**

# NEW ELEMENT – ELIGIBILITY OF R&I COSTS

Regulation establishing HORIZON, Article 2 – Definitions, paragraph (25h)

„coordination and support action“ means an action contributing to the objectives of the HORIZON programme, excluding research and innovation activities, except when undertaken under the component „widening participation and spreading excellence“ of the part „Widening Participation and Strengthening the ERA“; ...

Research and innovation costs are eligible in CSA for Widening instruments

# TEAMING FOR EXCELLENCE

116 PROPOSALS SUBMITTED

## RATIONALE

- MAIN AIM -- institution building: create new centres of excellence or substantially upgrade existing ones (2 phases abolished)
- Two-stage evaluation process (more details in FAQs)
- Complementary funding from other sources at least equal to the requested HORIZON grant (letter of commitment for the 2nd stage)
- Seal of Excellence to applications exceeding all evaluation thresholds but cannot be funded due to lack of budget available
- A research component up to 10% may include preparatory research project

- At least 2 HEIs from Widening country (or different WCs) and at least 2 internationally-leading institutions from 2 different MS or AC
- Entities benefiting from the European Universities initiative pilot funding of H2020 can participate but are excluded from funding

  - proposal submission as a single applicant (with identified future ERA Chair holder)
- Research costs are eligible up to 10%

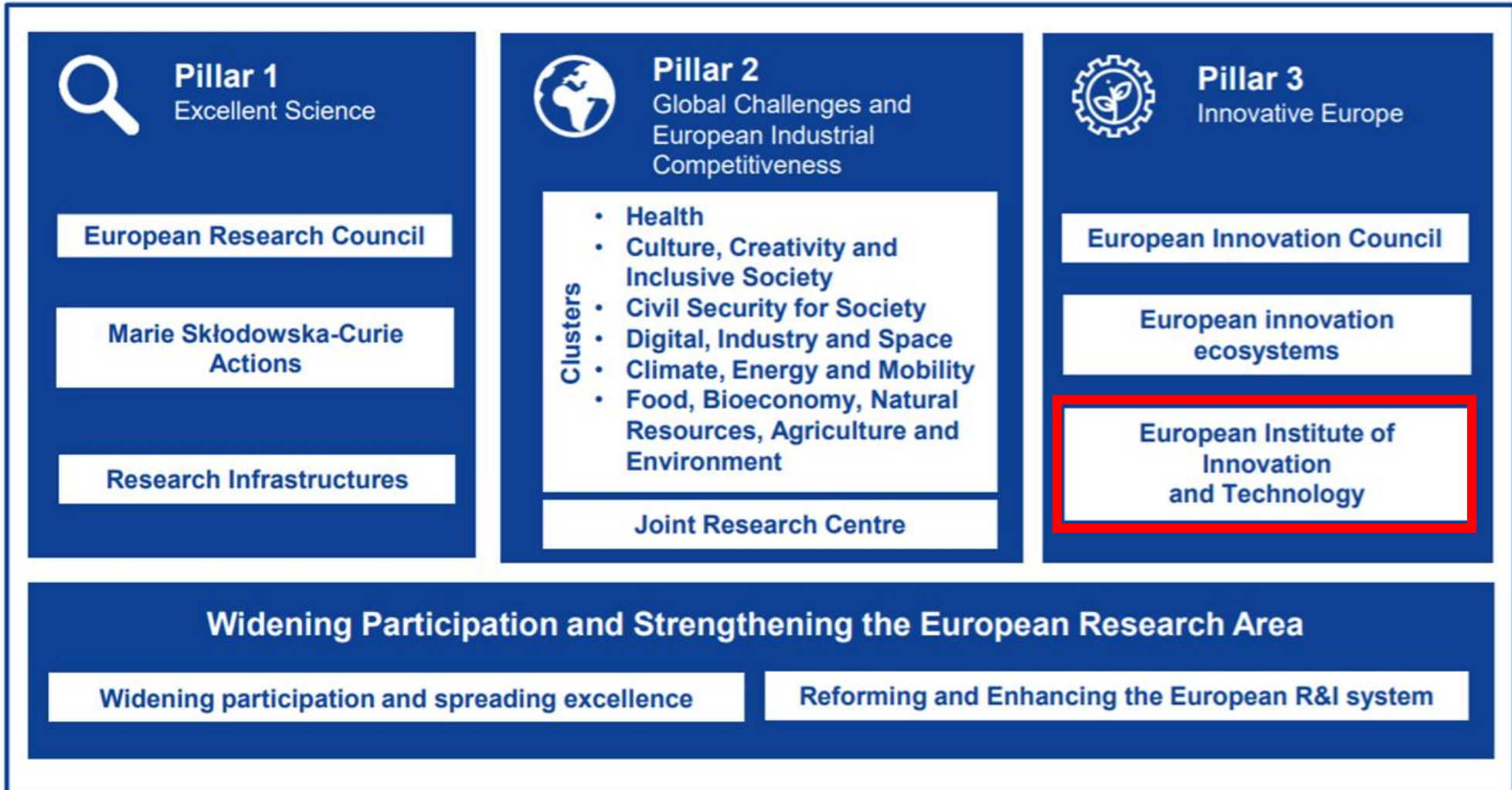

- Main aim: to strengthen Europe's ability to innovate
- Motto: Making innovation happen
- Originally financed directly from EU budget, since 2014 from FPs
- Integral part of Horizon Europe (Rules of Participation apply) **NEW**
- Strategic Innovation Agenda (SIA) 2021-2027 = strategic plan for 7 years
- National Contact Points nominated in 2021 **NEW**

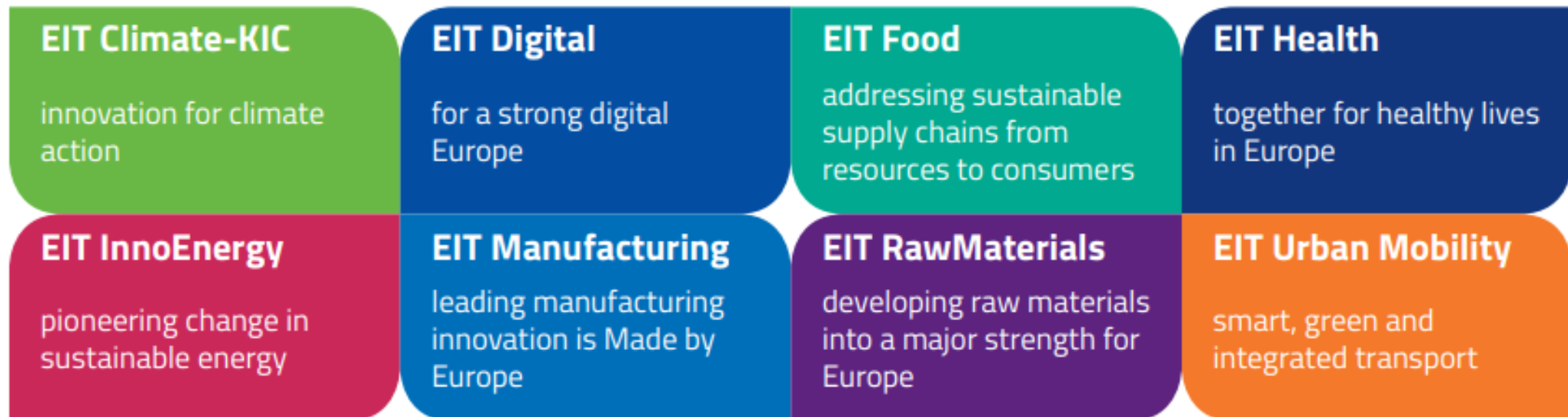

We have identified a number of innovation gaps where greater experimentation is needed to accelerate climate action and where we see that there is an opportunity to take a new approach to breaking through an intractable issue.

Through experimenting with these new approaches, we hope to learn about how to trigger system change and how to achieve our mission of a net-zero, resilient and just society by 2030 – now just nine years away.

We invite our community, including any new organisations that may wish to join, to prepare project proposals that aim to deliver work in between March 2022 and December 2023 that address one of the identified open positions. Funding is available to support the development of new commercial products or services that seek to launch on the market and achieve climate impact through entrepreneurship and commercial means. We aim to support innovators, researchers, scientists, coaches, and experts to join forces in projects that aim to bring innovative solutions to the European market. We will also support existing innovations that may seek to expand into new markets across Europe and require support to do so.

- Regional Innovation Scheme (RIS) – since 2016

- Eligible countries: 17 EU MS (Czechia included) and 11 AC to H2020 (modest and moderate innovators in EIS and with zero or lower participation in EIT)
- Implemented through EIT Innovation Hubs
- Objectives:
  - Widen KICs activities to RIS countries;
  - Share good practice, experience and know-how;
  - Offer tailor-made services
  - Boost innovation by linkages among key innovation actors



# EXAMPLES OF EIT RIS ACTIVITIES

- EIT Climate-KIC runs its EIT RIS [Accelerator](#) since 2016 supporting cleantech entrepreneurs and providing education, training, networking and grants
- Since 2018, EIT Digital runs a two-stage [ARISE Venture Programme](#) supporting the establishment of deep-tech-based ventures
- EIT Health introduced the [InnoStars Awards programme](#) specifically designed for business development and product validation in EIT RIS countries
- EIT InnoEnergy organises [PowerUp!](#) – the biggest competition for energy, cleantech, mobility, cybersecurity and smart city start-ups in CEE
- In 2017, EIT Health, EIT Food and EIT Raw Materials started an [EIT Jumpstarter](#), for early stage entrepreneurs that helps start-up teams to move their research from lab to market (joint by EIT InnoEnergy, EIT Manufacturing and EIT Urban Mobility in 2020)
- EIT Food organises a start-up competitions in the agrifood sector in 15 Eastern and Southern European countries - up to 10 innovative agrifood entrepreneurs compete in each country for [Innovation Prizes](#)

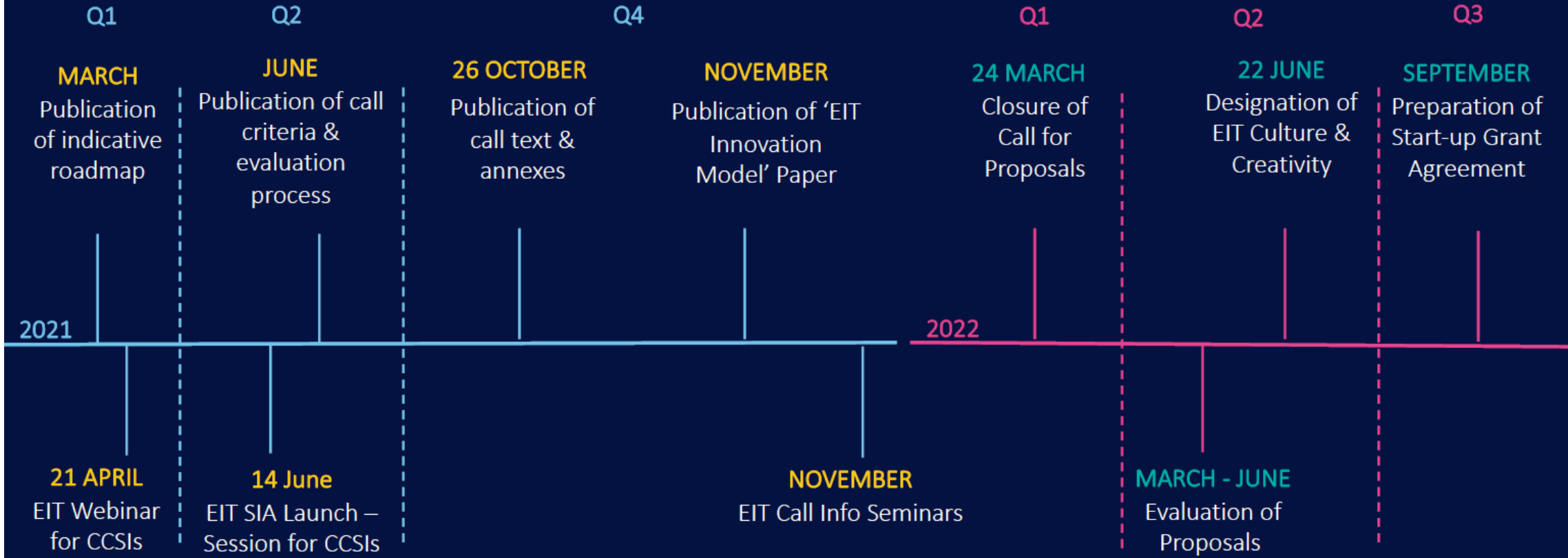

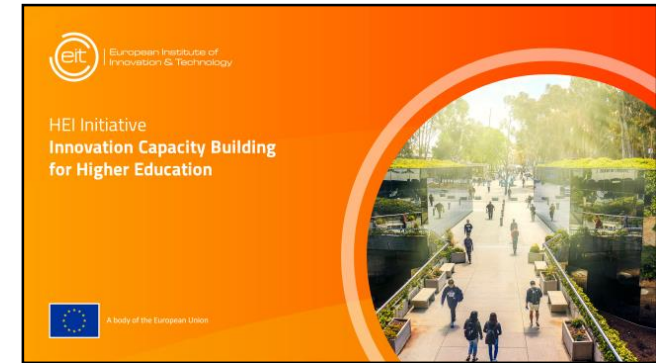

- New initiative to unlock the full innovation potential of Higher Education Institutions (HEIs)
- Main aim: Innovation Capacity Building for HE
- Opening: 24 March 2021, Deadline: 25 May 2021
- Budget per project: € 1.2 million max.
- up to € 400 000 for Phase 1 (July–December 2021)
- up to € 800 000 for Phase 2 (January 2022 - July 2023)
